MATTERS PROPOSED, DISCUSSED, OR DECIDED

HEIDI CONWAY WELCOMED EVERYONE TO THE COUNCIL AND WE BEGAN THE MEETING AT 11:20 AM. SHARLA BARBER WENT OVER MINUTES FROM SEPTEMBER'S MEETING. HEIDI CONWAY MOTIONED TO APPROVE THE MINUTES AND CHRIS BRONSON SECONDED THE MOTION. VOTE WAS UNANIMOUS.

MATT CHRISTENSEN UPDATED THE COUNCIL ON SAFETY PROCEDURES THAT ARE HAPPENING AROUND THE DISTRICT. SOME OF THESE INCLUDE ADDITIONAL SECURITY CAMERAS, SECURITY GATES FOR SCHOOL PARKING LOTS, STUDENT RESOURCE OFFICERS FOR JUNIOR HIGHS AND AN EMERGENCY APP FOR TEACHERS AND FACULTY.

MATT CHRISTENSEN WENT THROUGH THE SAFE TECHNOLOGY UTILIZATION AND DIGITAL CITIZENSHIP IN PUBLIC SCHOOLS REQUIREMENT. THE COUNCIL DISCUSSED THE DISTRICT'S FILTERS, MANAGEMENT SYSTEMS AVAILABLE, AND PROTOCOLS FOR WHEN INAPPROPRIATE CONTENT IS ACCESSED OR ATTEMPTED BY STUDENTS, PARENTS, OR EMPLOYEES.

SHARLA BARBER UPDATED THE MEMBERS ON WHAT HAS BEEN HAPPENING IN THE COUNSELING OFFICE. THE ACT PREP BOOT CAMP WAS LAST SATURDAY
