RULES—by signing below you agree to abide by the following rules:

- Participants will receive a wristband that must be worn at all times for all activities.
- Participants must participate in service activities.
- Participants will receive a light breakfast in the morning and a midnight snack provided by our sponsors. If you have food allergies or preferences, or feel you need more, bring your own food. **Once students enter they cannot leave until 5:00 am unless they are released to a parent or guardian. Parental permission to leave must be in writing or in person.**
- Participants must understand that staying up all night may cause them to experience symptoms of headache, stomachache, and other general health issues. **Participants with minor symptoms will not be allowed to leave unattended but will only be released to parents who appear in person.**
- Participants must provide their own blankets, clothing, chairs, etc. to stay warm and/or comfortable. No mattresses, tents, or enclosed shelter will be allowed. **All personal items, couches, chairs, etc. must be removed from the school by 5:30 am on February 28, 2015.**
- Adult supervision and security will be maintained throughout the event.
- Students must follow any and all rules determined by Spanish Fork High School Administration & Security. No public display of affection, possession of illegal substances, shoplifting, theft or vandalism of any kind, possession of weapons or firearms of any kind, or doing anything harmful to yourself or others will be permitted and may be punishable by law.
- All participants must be currently attending high school, grades 10-12.
- Failure to comply with all rules may lead participant to be excused and released to a parent or guardian and forfeit registration fees.

ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING IN THIS ACTIVITY OR EVENT, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault. I certify that I am physically fit, have sufficiently prepared or trained for participation in the activity or event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this activity or event. I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity or event in which I may participate, and that it will govern my actions and responsibilities at said activity or event. In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: Spanish Fork High School, Tabitha's Way, and/or their directors, officers, employees, volunteers, representatives, and agents, the activity or event holders, activity or event sponsors, activity or event volunteers; (B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise. I acknowledge that SFHS and their directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of SFHS. I acknowledge that this activity or event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to participants but are also present for volunteers. I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity or event. I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
